Mediation Training Program

Waymakers - Dispute Resolution Services (DRS) offers this 25-hour mediation training for individuals interested in mediating in California. The program exceeds the California Dispute Resolution Programs Act (DRPA) training requirements. Participants who attend every session will receive a certificate of completion. DRS welcomes volunteer applicants who are interested in mediating with the DRS program.
